Terms of Service

Please read these Terms of Service (collectively with Unlimited Labs, Inc.'s (d/b/a B12) Privacy Policy b12.io/privacy and DMCA Copyright Policy below, the "Terms of Service") fully and carefully before using <u>www.b12.io</u> (the "Website") or any of the services, features, Content (defined below) or applications made available by Unlimited Labs, Inc. ("B12" or "our") through the Website, including without limitation B12's website design and hosting platform (the "Platform") (collectively, the "Services"). These Terms of Service set forth the legally binding terms and conditions for your use of the Services. IF YOU ARE USING THE SERVICES ON BEHALF OF AN ENTITY, YOU REPRESENT AND WARRANT THAT YOU HAVE ALL NECESSARY RIGHT, AUTHORITY AND CONSENT TO BIND SUCH ENTITY. IN SUCH CASES, ALL REFERENCES TO "YOU" OR "YOUR" SHALL REFER TO BOTH THE INDIVIDUAL AND THE ENTITY.

1. Acceptance of Terms of Service.

- a. By registering for and/or using any of the Services in any manner, including visiting or browsing the Website, you agree to these Terms of Service and all other operating rules, policies and procedures that may be published from time to time through the Services by B12, each of which is incorporated by reference and each of which may be updated from time to time with or without notice to you.
- b. Certain of the Services may be subject to additional terms and conditions specified by B12 from time to time; your use of such Services is subject to those additional terms and conditions, which are incorporated into these Terms of Service by this reference.
- c. These Terms of Service apply to all users of the Services, including, without limitation, users who are contributors of content, information, and other materials or services, registered or otherwise.
- d. ARBITRATION NOTICE AND CLASS ACTION WAIVER: EXCEPT FOR CERTAIN TYPES OF DISPUTES DESCRIBED IN THE ARBITRATION SECTION BELOW, YOU AGREE THAT DISPUTES BETWEEN YOU AND B12 WILL BE RESOLVED BY BINDING, INDIVIDUAL ARBITRATION AND YOU WAIVE YOUR RIGHT TO PARTICIPATE IN A CLASS ACTION LAWSUIT OR CLASSWIDE ARBITRATION.

2. Eligibility.

a. You represent and warrant that you are at least 18 years of age. If you are under age 18, you may not, under any circumstances or for any reason, use the Services. B12 may, in our sole discretion, refuse to offer the Services to any person or entity and change its eligibility criteria at any time. You are solely responsible for ensuring that these Terms of Service and your use of the Services (a) are in compliance with all laws, rules and regulations applicable to you and (b) do not violate any other agreement to which you are a party. The right to access the Services is revoked where these Terms of Service or use of the Services is prohibited or to the extent offering, sale or provision of the Services

conflicts with any applicable law, rule or regulation. Further, the Services are offered only for your use, and not for the use or benefit of any third party.

3. Registration.

a. To register for an account on the Services you must provide an email address and create a password (an "Account"). You must provide accurate and complete information and keep your Account information updated. You shall not: (i) select or use as a username a name of another person with the intent to impersonate that person; (ii) use as a username a name subject to any rights of a person other than you without appropriate authorization; or (iii) use, as a username, a name that is otherwise offensive, vulgar or obscene. You are solely responsible for the activity that occurs under your Account, and for keeping your Account password secure. You may never use another person's user Account or registration information for the Services without permission or share your Account or access credentials with any other individual. You should never publish, distribute or post login information for your Account. You must notify us immediately of any change in your eligibility to use the Services or breach of security or unauthorized use of your Account. You have the ability to delete your Account, either directly or through a request made to one of our employees or affiliates, but Account deletion requests are subject to any additional terms governing use of any Paid Services (as defined below) for which you have signed up.

4. The Services.

- a. **Services**. Subject to these Terms of Service, B12 will use commercially reasonable efforts to make the Services available to you.
- b. Content. "Content" means information, data, text, photographs, videos, audio clips, artwork, designs, templates, written posts and comments, software, scripts, graphics, and interactive features generated, provided, or otherwise made accessible on or through the Services. Excluding Customer Content (as defined below and which shall be owned by you and licensed to B12 in accordance with these Terms of Service), B12 hereby grants you a nonexclusive, non sublicensable and non-transferable license to use and display all other Content solely for purposes of using the Services for your personal internal use on your own behalf. Use, reproduction, modification, distribution or storage of any Content (other than Customer Content (as defined below)) for any purpose other than using the Services is expressly prohibited without prior written permission from B12. As between the parties, all Content, except for Customer Content, is owned by B12 or its licensors. You acknowledge that all Content accessed by you while using the Services is at your own risk and you will be solely responsible for any damage or loss to you or any other party resulting therefrom.
- c. **Restrictions on Use of the Services**. You will not directly or indirectly (i) sell, license, sublicense, distribute, copy, rent or lease the Services or any Content, or include the Services in a service bureau, timeshare outsourcing offering, or otherwise make the Services available to, or use the Services for the benefit of, any third party, or transfer any of the rights that you receive hereunder; (ii) interfere with or disrupt the integrity or performance of the Services, or any third party data contained therein, or attempt to gain

unauthorized access to the Services or its related systems or networks; (iii) copy, modify, translate, or create derivative works based on the Services, Content or any underlying software or any part, feature, function or user interface thereof, including by framing or mirroring any part of any Services or any Content; (iv) access or use the Services for benchmarking or similar competitive analysis purposes or in order to build a competitive product, service or website; (v) decompile, disassemble, decipher or reverse engineer the Services, or otherwise attempt to derive any source code or underlying ideas or algorithms of any part of the Services (except to the extent such restriction is prohibited by applicable statutory law); (vi) remove any copyright notices, information, and restrictions contained in the Services or any Content; (vii) bypass, circumvent or attempt to bypass or circumvent any measures B12 may use to prevent or restrict access to the Services (or other accounts, computer systems or networks connected to the Services) or take any action that imposes or may impose (as determined by B12 in our sole discretion) an unreasonable or disproportionately large load on our (or our third party providers') infrastructure; (viii) use manual or automated software, devices, or other processes to "crawl" or "spider" any page of the Website or Services; or (ix) otherwise take any action in violation of our guidelines and policies, including these Terms of Service.

- d. Availability. B12 will not be responsible or liable for any failure in the Platform or Services resulting from or attributable to (i) Customer Content, or failures to deliver Customer Content to B12; (ii) failures in any telecommunications, network or other service or equipment outside of B12's facilities; or (iii) any force majeure event or other cause beyond B12's reasonable control. B12 does not guarantee that the Services or any Content will be available, or that any Content that is available is or will continue to be accurate. 5. Customer Content.

a. Definition. "Customer Content" means (i) any and all electronic data, content and information submitted to the Services or B12 by you or by a third party on your behalf, or that is collected and processed by you or by a third party on your behalf directly in connection with your use of the Services ("Customer Data") (ii) any trademarks, trade names, logos, service marks, branding materials, designs or artwork provided to the Services or B12 by you or by a third party on your behalf ("Customer Marks"), and (iii) any custom trademarks, logos, written text or artwork that B12 agrees in writing to design or create specifically for you as a commissioned work for hire.

- b. License to Customer Content. By using the Services, including by providing your Customer Content, you hereby grant B12 a nonexclusive, worldwide, royalty free, fully paid right and license to use, copy, access, process, reproduce, perform, display, modify, distribute and transmit your Customer Content on the Platform and in connection with providing the Services to you. You acknowledge and agree that (i) the quality of the Services and the Platform depend on the uploading or other provisioning of the Customer Content into the Platform or the Services, as applicable, and (ii) B12 will not assume any responsibility for, or undertake to verify, the legality, accuracy or completeness of the Customer Content provided by you or on your behalf, all of which shall be your sole responsibility.
- c. Representations and Warranties. You represent, warrant and covenant that (i) all Customer Content is accurate and compliant with all applicable laws, rules and regulations; (ii) you own all rights, title and interest in and to the Customer Content, or have otherwise secured all necessary rights in the Customer Content as may be necessary to permit the access, use and distribution thereof as contemplated by these Terms of Service; (iii) you shall only use the Services in accordance with all applicable laws, rules and regulations, these Terms of Service and any relevant documentation provided by B12; and (iv) you will not, and will not permit any third party to upload, download, post, submit, provide, transmit, distribute or otherwise make available to or through the Services any content or data that (A) is unlawful, infringing, deceptive, fraudulent, invasive of another's privacy, tortious, obscene, or that otherwise violates any other right of any third party, including any intellectual property, proprietary or privacy rights, or that is otherwise inappropriate, as determined by B12 in our sole discretion; (B) contains any viruses, code, malware, files, trojan horses, or programs designed or intended to disrupt, damage, limit or interfere with the proper function of any software, hardware, or telecommunications equipment or that is or can be otherwise malicious or disruptive; (C) constitutes unauthorized or unsolicited advertising, junk or bulk email ("spamming") or otherwise violates federal <u>CAN-SPAM</u> regulation; or (D) contains any personally identifying information that is subject to specialized security regimes including without limitation the Health Insurance Portability and Accountability Act ("HIPAA") and the standards promulgated by the PCI Security Standards Council. You acknowledge and agree that B12 is not a "Business Associate" under HIPAA, and you will not provide any protected health information to the Services or to B12. If you do not adhere to any of the preceding, B12 has the right to terminate your account without a refund.

6. Third Party Services.

The Services may integrate with or permit you to link to other websites, plug-ins, services or resources on the Internet, and other websites, plug-ins, services or resources may contain links to the Services. When you access third party resources, you do so at your own risk. These other resources are not under our control, and you acknowledge that B12 is not responsible or liable for the content, functions, accuracy, legality, appropriateness or any other aspect of such resources. The inclusion of any such link or the availability or use of any such integration does not imply our endorsement or any association between B12 and their operators. You further acknowledge and agree that B12 shall not be responsible or liable, directly or indirectly, for any damage or loss caused or alleged to be caused by or in connection with the use of or reliance on any content, goods or services

available on or through any such resource. B12 will also not be responsible or liable for any failure in the Services attributable to your or any third party's products, services, negligence, willful misconduct, breach of this Agreement or other unauthorized access or use.

7. Payments and Billing.

- a. Paid Services. Certain of our Services are or may in the future become subject to payments (the "Paid Services"). Please see our Paid Services page (https://www.b12.io/pricing) for a description of the currently available Paid Services and to sign up for Paid Services. Please note that any payment terms presented by B12 to you in the process of using or signing up for a Paid Service are deemed part of these Terms of Services. All amounts are stated in, and shall be paid in, U.S. dollars. B12 does not transmit invoices automatically, but they can be provided in PDF format from our billing department upon your request to billing@b12.io.
- b. Payment; Late Fees. By signing up to receive any Paid Services, you agree to pay B12, in accordance with all applicable payment terms set forth on B12's Paid Services page and herein, the Fees for such Paid Services, and you authorize B12, through the Payment Processor (defined below), to charge your chosen payment provider ("Payment Method") for the applicable Fees and agree to make payment using that selected Payment Method. Unpaid invoices are subject to a finance charge of 1.5% per month on any outstanding balance, or the maximum permitted by law, whichever is lower, plus all expenses of collection (including, without limitation, reasonable attorney's fees). If our collection efforts fail, unpaid debts will be reported to all available credit reporting agencies. Any account that is 15 days past due is subject to suspension of the Services. Any account that is 30 or more days past due may be terminated.
- c. **Taxes**. Fees are exclusive of any taxes. You shall be responsible for all taxes, tariffs, levies and duties associated with the Services other than U.S. taxes based on B12's net income.
- d. **Billing.** B12 uses a third party payment processor (the "Payment Processor") to bill you through a payment account linked to your Account on the Services (your "Billing Account") for use of the Paid Services. The processing of payments will be subject to the terms, conditions and privacy policies of the Payment Processor in addition to these Terms of Service. - e. **Auto Renewal.** Fees for Paid Services ordered on a subscription or auto-renewing basis will be automatically charged their agreed upon subscription amount on the agreed upon schedule. When signing up for a Paid Service, you will be able to select a recurring billing level and renewal term ("Subscription"). SUCH NOTICE WILL NOT AFFECT CHARGES SUBMITTED BEFORE B12 REASONABLY COULD ACT. TO TERMINATE OR ALTER YOUR SUBSCRIPTION PLEASE CONTACT OUR SUPPORT TEAM AT HELLO@B12.IO. This does not waive our right to seek payment directly from you.

- f. **Current Information Required**. YOU MUST PROVIDE CURRENT, COMPLETE AND ACCURATE INFORMATION FOR YOUR BILLING ACCOUNT. YOU MUST PROMPTLY UPDATE ALL INFORMATION TO KEEP YOUR BILLING ACCOUNT CURRENT, COMPLETE AND ACCURATE (SUCH AS A CHANGE IN BILLING ADDRESS, CREDIT CARD NUMBER, OR CREDIT CARD EXPIRATION DATE), AND YOU MUST PROMPTLY NOTIFY B12 OR OUR PAYMENT PROCESSOR IF YOUR PAYMENT METHOD IS MODIFIED OR CANCELED (E.G., FOR LOSS OR THEFT) OR IF YOU BECOME AWARE OF A POTENTIAL BREACH OF SECURITY, SUCH AS THE UNAUTHORIZED DISCLOSURE OR USE OF YOUR ACCOUNT CREDENTIALS OR PASSWORD. - g. Cancelling or Changing Paid Services. To change or cancel your Paid Services at any time, contact B12 at hello@b12.io. Any request for cancellation must be sent at least ten (10) business days prior to the end of the Subscription term to allow for adequate processing time. Your nontermination or continued use of the relevant Paid Service reaffirms that B12 is authorized to charge your Payment Method the Fees for such Paid Service, including any associated fees (e.g. overage fees or late fees, to the extent applicable). - j. **Chargeback Policy; Disputes**. If you have a question about charges made to your Account, please contact B12 immediately at hello@b12.io. If the charges were made in error, B12 will credit your Billing Account or Payment Method for the appropriate amount. Please note that B12 has a zero tolerance policy for chargebacks. Any customer who disputes a credit card payment that is found to be valid may be permanently banned by B12 from use of any and all B12 Services.

 - iv. Contact information about the notifier including address, telephone number and, if available, email address;
 - v. A statement that the notifier has a good faith belief that the material is not authorized by the copyright owner, its agent, or the law; and
 - vi. A statement made under penalty of perjury that the information provided is accurate and the notifying party is authorized to make the complaint on behalf of the copyright owner.

9. Termination.

- a. Termination by Either Party. You have the option of canceling your Account at any time by following the instructions in Section 7(g) or otherwise available through the Services, subject to any terms applicable to Paid Services for which you have signed up. B12 reserves the right to terminate your Account or access to all or any part of the Services at any time, with or without cause, with or without notice, effective immediately without refund. All provisions of these Terms of Service which by their nature should survive termination or expiration shall survive termination, including ownership provisions, warranty disclaimers, indemnity and limitations of liability.
- b. Customer Content after Termination. Termination or cancellation of your Account by either party may result in the forfeiture and destruction of all information, content and data, including Customer Content, associated with your Account. An Account terminated by B12 will not be backed up for any reason and will be immediately deleted from our servers. IN NO EVENT SHALL B12, NOR OUR DIRECTORS, EMPLOYEES, AGENTS, PARTNERS, SUPPLIERS OR CONTENT PROVIDERS, BE LIABLE UNDER CONTRACT, TORT, STRICT LIABILITY, NEGLIGENCE OR ANY OTHER LEGAL OR EQUITABLE THEORY WITH RESPECT TO THE SERVICES (A) FOR ANY LOST PROFITS, DATA LOSS, COST OF PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES, OR SPECIAL, INDIRECT, INCIDENTAL, PUNITIVE, COMPENSATORY OR CONSEQUENTIAL DAMAGES OF ANY KIND WHATSOEVER (HOWEVER ARISING); (B) FOR ANY BUGS, VIRUSES, TROJAN HORSES, OR THE LIKE (REGARDLESS OF THE SOURCE OF ORIGINATION); OR (C) FOR ANY DIRECT DAMAGES IN EXCESS OF (IN THE AGGREGATE) OF THE GREATER OF (I) FEES PAID TO B12 FOR THE PARTICULAR SERVICES DURING THE IMMEDIATELY PREVIOUS THREE (3) MONTH PERIOD OR (II) \$500.00.

- 13. Arbitration.
 - a. ALL DISPUTES BETWEEN YOU AND B12 (WHETHER OR NOT SUCH DISPUTE INVOLVES A THIRD PARTY) WITH REGARD TO YOUR RELATIONSHIP WITH **B12, INCLUDING WITHOUT LIMITATION DISPUTES RELATED TO THESE** TERMS OF SERVICE, YOUR USE OF THE SERVICES, AND/OR RIGHTS OF PRIVACY AND/OR PUBLICITY, WILL BE RESOLVED BY BINDING, INDIVIDUAL ARBITRATION IN NEW YORK, NEW YORK UNDER THE STREAMLINED ARBITRATION RULES AND PROCEDURES ("RULES") OF JAMS, INC. ("JAMS") THEN IN EFFECT, BY ONE COMMERCIAL ARBITRATOR WITH SUBSTANTIAL EXPERIENCE IN RESOLVING INTELLECTUAL PROPERTY AND COMMERCIAL CONTRACT DISPUTES, WHO SHALL BE SELECTED FROM THE APPROPRIATE LIST OF JAMS ARBITRATORS IN ACCORDANCE WITH SUCH RULES, AND YOU AND B12 HEREBY EXPRESSLY WAIVE TRIAL BY JURY. DISCOVERY AND RIGHTS TO APPEAL IN ARBITRATION ARE GENERALLY MORE LIMITED THAN IN A LAWSUIT, AND OTHER RIGHTS THAT YOU AND B12 WOULD HAVE IN COURT MAY NOT BE AVAILABLE IN ARBITRATION.
 - b. As an alternative, you may bring your claim in your local "small claims" court, if permitted by that small claims court's rules and if within such court's jurisdiction, unless such action is transferred, removed or appealed to a different court. You may bring claims only on your own behalf. Neither you nor B12 will participate in a class action or classwide arbitration for any claims covered by this agreement. YOU ARE GIVING UP YOUR RIGHT TO PARTICIPATE AS A CLASS REPRESENTATIVE OR CLASS MEMBER ON ANY CLASS CLAIM YOU MAY HAVE AGAINST B12 INCLUDING ANY RIGHT TO CLASS ARBITRATION OR ANY CONSOLIDATION OF INDIVIDUAL ARBITRATIONS. You also agree not to participate in claims brought in a private attorney general or representative capacity, or consolidated claims involving another person's account, if B12 is a party to the proceeding. You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of, related to or connected with the use of the Services or these Terms of Services must be filed within one (1) year after such claim of action arose or be forever banned.
 - c. Severability. If the prohibition against class actions and other claims brought on behalf of third parties contained above is found to be unenforceable, then all of the preceding language in this Arbitration section will be null and void. This arbitration agreement will survive the termination of your relationship with B12.

14. Governing Law and Jurisdiction.

These Terms of Service shall be governed by and construed in accordance with the laws of the State of New York, including its conflicts of law rules, and the United States of America. You agree that, subject to Section 13, any dispute arising from or relating to the subject matter of these Terms of Service shall be resolved in New York County, New York.

15. Modification.

B12 reserves the right, in our sole discretion, to modify or replace any of these Terms of Service, or change, suspend, or discontinue the Services (including without limitation, the availability of any feature, database, or content) at any time by posting a notice on the Site or by sending you notice through the Services, via email or by another appropriate means of electronic communication. B12 may also impose limits on certain features and services or restrict your access to parts or all of the Services without notice or liability. While B12 will provide timely notice of modifications, it is also your responsibility to check these Terms of Service periodically for changes. Your continued use of the Services following notification of any changes to these Terms of Service services going forward.
